## FURNITURE DESIGN AWARD 2012



**AIM OF THE COMPETITION**  
PORADA ARREDI S.r.l. in cooperation with POLI.design, a Consortium of Politecnico di Milano, announces an international ideas competition to find innovative concepts for a living area collection. The use of wood should be prevalent, but not exclusive, and the collection should embody the values and the identity of Porada production. The wood could be combined with metal, glass and other materials and also integrated with some technological devices. The designs submitted must be original and unpublished. They must enhance the use of production technologies and processes typical of solid wood and they must respond to the principle of functionality. They should comply with current safety standards, with ergonomic characteristics, with both environmental and sustainable design characteristics.

**TERMS OF PARTICIPATION**  
The competition is open to

all Italian and foreign designers, creative artists, professionals and non-professionals, employees of companies (if duly authorized by their company), and students. Group entries are allowed; in this case, the members of the group must choose a leader, who will receive any possible information from the organizers of the competition. Designs must be unpublished, original and expressly developed for the competition. By entering the competition, the participant unconditionally accepts the terms of the competition rules contained herein and likewise the jury's decisions. Each participant can present only one project.

### APPLICATION FOR PARTICIPATION

Participants should register using the online form available on the webpage [www.porada.it](http://www.porada.it) including the participant's personal data, tax code, address, home/office telephone numbers, mobile telephone number, e-mail address, the product typology for which

participant intends to take part and a declaration of having understood the competition rules herein and their unconditional acceptance.

#### **MATERIAL REQUIRED**

1. a text (max 3500 characters) outlining the motivations, the general concept, design features and a description of the materials intended to be used;
2. project consists of 3 x A2 tables horizontally (42 x 59.4 cm), black and white or coloured (the layout of the table can be downloaded from [www.porada.it](http://www.porada.it)) mounted on a rigid and light support (5 mm max thickness) with an appropriate scale. The tables must be developed as follows:
  - Table 1: An overview, scenarios and terms of use, rendering, general concept of the object
  - Table 2: Technical drawings: plans elevations, sections, isometric views and construction details
  - Table 3: representation of the object with participant's favourite technique, renderings, picture of the model
3. a scale model (optional);
4. a CD-rom with the high resolution drawings in pdf format (image size 42x59,4 cm)

The package should be clearly marked with the title "PORADA FURNITURE DESIGN AWARD 2012". As well as the specified materials, the package should also contain an envelope indicating the entrant's personal data and the duly filled-in form downloaded from the website.

Any delivery cost charged to the addressee will be refused and the package will be sent back to the sender. The entrants commit themselves to declare to the carrier/courier/agency in charge of the delivery that their package has no commercial value and to grant the payment of any possible Delivery Duty Paid as well as of any possible Customs Duty.

**PORADA FURNITURE DESIGN AWARD 2012**

The proceedings of the jury will not be published; a final report will be published, with the prize-winners, along with commended and selected entries. The jury's decisions are taken by majority vote; its decisions are final and indisputable. The jury must complete its work by 31st January 2013.

#### **EVALUATION CRITERIA**

The selection and evaluation of the designs will consider their originality, their degree of innovation and search of innovative solutions with reference to the typical working processes applied to solid wood, experimentation in materials and surface finish, the functional, ergonomic, safety-related and environmental characteristics of the product, the capability of the designs in defining and anticipating sceneries of innovative use for contemporary furniture and accessories, with particular attention to the determination of typological, technological and morphological characteristics of a contemporary living area, even through the integration with automated electronic devices and new functionalities expressed by information technology and communication.

#### **PRIZES AND RECOGNITION**

The total prize money, € 7.000,00 will be divided as follows:

1st prize	€ 4.000,00
2nd prize	€ 2.000,00
3rd prize	€ 1.000,00

The company Porada reserves the right to make prototypes of the winning designs and to produce them.

#### **RIGHTS OF EXPLOITATION AND OWNERSHIP OF THE WORKS**

Participants in the competition maintain the ownership and rights of exploitation of their works. Porada reserves the right to stipulate a contract with the authors of the award-winner project or commended concepts for the industrial exploitation of the designs. The participants grant to Porada the option to use the award-winner designs for the period of one year from the date of the jury's report. Within this period, Porada will evaluate the possibility of putting the designs into production and in that case the business relationship with the designer will be governed by a specific contract. Porada commit itself not to modify the designs presented in any way without the designer's authorization. Porada may request a one-year option also on the designs that have not won a prize, in return of a payment that will be agreed between the parties.

#### **ANNOUNCEMENT AND PUBLICATION OF THE COMPETITION RESULTS**

The results of the jury's considerations will be communicated to the winners by e-mail within the specified date. Porada will present the competition to the specialist press and the competition results will be announced during an event, for which information will be issued in due course.

All participants expressly authorize Porada to exhibit their designs publicly (during exhibition or any other kind of event) and to publish their designs in a catalogue or in specialist publications; nothing will be owed to the participants for this, except the obligation of quoting the authors' names.

#### **RETURN OF COMPETITION MATERIALS**

The materials submitted can be requested to the address where they had been sent originally within a period of thirty days following the announcement of the award-winners. After this period, the organizers decline all responsibility for the conservation of the submitted materials.

Those materials, which will not be requested back in the due time will not be sent back. The return of the materials is at participant own expenses. The competition organizers decline all responsibility in the case of loss, theft or deterioration of the materials.

#### **AUTHORISATION**

With regards to the Italian law 675/96 relating to the protection of privacy, the participants to the competition expressly authorize the competition organizers to process their personal data as necessary for running of the competition itself.
